La Crosse County submitted a proposal for Shared Services which was approved. Our Change Reporting Center will be making changes for the counties of Buffalo, Clark, Jackson, Monroe, Pepin, and Vernon. La Crosse County is in the process of hiring four new personnel to staff the Shared Services Program. Shared Services hopefully targeted for start-up the middle of June or July 1<sup>st</sup> at the latest.
