Motion by Fred Marini/Glenn Seager to keep the Audio Visual classification and the \$.25 per day fine. **MOTION** passed on a vote of 6 ayes, 1 nay – Mary Bach Filla.

WRLS TECHNOLOGY PLAN:

A Technology Plan is needed to meet state requirements for state and Federal grants. Those libraries without their own technology plan can file using the WRLS plan. The board believes the WRLS Plan budget figures are not specific and is not comfortable supporting it in this format.

Chris was directed by the board to pursue clarification with David on a number of items including projected budget figures, future technology support and the multi-type structure of WRLS.

Motion by Fred Marini/Arlene Benrud to reject the WRLS Technology Plan for lack of budget detail. **MOTION** carried unanimously.
