Poverty Task Force Update/Community Collaboration Committee

Another presentation by La Crosse County Human Services Economic Support Supervisor, Tom Miller, is scheduled for today at the Neighborhood Community Church. They are hoping to give mentors or persons who work with persons in need more information about the services that are available to people in the community.

W2 UPDATE

Tom Miller gave an update of the W2 Program and changes that have taken place and changes upcoming. W2 payments will be reduced by \$20 a month and the sanction amount per hour will go down to \$5.00 per hour. The 24 month and 60 month clocks for persons on W2 will be returning. Caretaker of a newborn has gone from 12 weeks to 8 weeks.

W2 CASE WORKERS DISCUSSION OF THEIR ROLES, CHALLENGES AND SUCCESSES

Joan Halverson, Ya Vang and Linda Short explained their roles in W2 and the clients they serve. Linda has been working to find clients new skill sites and has been very successful. Joan and Ya are seeing more people with multiple barriers that make it more difficult to place and find jobs. Criminal backgrounds seem to be more common and also make it more difficult in finding employment.
