CALL TO ORDER

APPROVAL OF NOVEMBER 10, 2010 and DECEMBER 8, 2010 MINUTES OF CRIMINAL JUSTICE MANAGEMENT EXECUTIVE COMMITTEE

REPORT ON DISPROPORTIONATE MINORITY CONTACT TRAINING

The training by Dr. Lori Fridell in December of 2010 went very well. Captain Lawrence indicated that the City now has 11 people trained in disproportionate minority contact and he would like to see all law enforcement trained in this topic. He has talked to Dr. Fridell on a couple of different occasions and would like her back for all law enforcement for the entire area. The question is how we go about it. Possibly we could do a "training of the trainers" type of thing. It would be nice if she were to put out some type of product such as a Powerpoint presentation or a video, etc. to share with everyone. Captain Lawrence will call Lindsey Draper and Dr. Fridell again just to let them know that we are interested in having the training done here for the entire area. The CJMC will keep on the agenda for 2011 for continued discussion.

EVIDENCE BASED DECISION MAKING/SYMPOSIUM

In 2010, the CJMC identified the need to have some type of symposium regarding evidence based decision making. We had applied for technical assistance to help us through this process but did not get it. Jane did contact Mark Carey who thought it would be helpful to get a group together including law enforcement, prosecutors, defense, judges, probation agents at the table. The first half day could be a global overview on evidence based practice, and then each section of people would go into their own little groups to discuss further and what it means for that particular section. This topic will be put on a lower priority than Disproportionate Minority Contact Training. Evidence Based Decision Making will be more of a priority after that – maybe in 2 years. In the meantime, there should be more information going back and forth between the different branches and possibly have some of this topic be a part of the inservices that are held internally.
