CALL TO ORDER

Chair Monica Kruse called the meeting to order at 5:55 PM.

ANNOUNCEMENTS

Welcome New Board Member

New board member welcomed, and introductions were made. Doug Mormann was recognized for participating in an unplanned event by spending his birthday assisting and chaperoning at the emergency cooling center.

June County Board Action

The following three Resolutions passed unanimously: 1) Resolution Requesting that the Department of Health Services Incentivize More Effective Regional Collaboration, Cost Savings and Efficiency in Income Maintenance (IM) Administration by Bringing More Equity to Calendar Year 2013 Consortia Funding Allocations; 2) Resolution Requesting the State of Wisconsin to Suspend the Current Request for Proposal (RFP) for Wisconsin Works (W-2); and 3) Resolution in Support of Policy Tax Equity on Other Tobacco Products.

Board Members Report on Conferences/Meetings

Chair Monica Kruse announced an opportunity to attend a Public Health Nursing Conference in Stevens Point on August 20 and 21.

Mental Health Recovery Services Advisory Committee

Chair Monica Kruse asked for a board volunteer to be a representative on the Mental Health Recovery Services Advisory Committee. This committee is charged with the oversight of the Community Options Program (COP) and the Comprehensive Community Services (CCS) program. It is required by ordinance that a HHS board member be part of the committee. Anyone interested should contact Monica.

BOARD EDUCATION

Policy, Practice, People - Home Health Care

Connie Eide, supervisor of the Home Health Care program, introduced Andrea and Luke. They have been clients for approximately 8 years. Andrea is a single mom, Luke is 16 ½ yrs old, has seizures, cerebral palsy, mental retardation and other medical challenges he has had since birth. The Home Health Care program and providers give mom respite as Luke requires attention 24 hours per day. Currently the family is receiving services both for mom and son five days a week.

There is a need for this type of service as clients need skilled staff for care. David Trapp mentioned many insurance companies are looking at terminating the benefits for home health care, but the need will not be going away. Connie advised the current staffing for the Home Health Care Program is Connie at .5 FTE plus five home health aide and 3 RN staff, none of which are full time equivalent. Karin Johnson thanked the clients for presenting. Steve O'Malley stated we have every intention of preserving the program with the 2013 budget; however, this is not a mandated program.

Policy, Practice, People - Nutrition - Strong Seniors Program

Liz Haag works with the Health Nutrition program in the Health Department. She currently is an instructor in the "Strong Seniors Strong Bones" program. This program is based on evidence based practice. Currently the Health Department has 11 classes (25-30 people each class) throughout the county. A video was presented on the program. (preventionspeaks.org)

Testimony from Jean who has been participating in the program from the beginning. The program helped her with toning, strengthening and kept her muscles and bones strong. She lost 40 pounds since the start of the program which she attributes to not only her work, but also the enthusiastic, motivating, great instructors who deliver an inspiring program, nutrition and healthy eating tips.

Testimony from Phil who retired from the work force in April. In the past 34 years, other than treadmills and other cardio workouts, Phil had no other focus on the strength of his muscles and bones. Since Phil started with the program, he is amazed at the increased strength and flexibility he is experiencing.

Accreditation - Domain 6: Enforce Public Health Law

Doug Mormann discussed Domain 6: Enforce Public Health Law, the sixth step in attaining the National Accreditation as a high performing local Health Department.

RESOLUTIONS

Resolution Re: Accept Contract for Harvest of the Month Partnership

Mormann presented on this resolution as a continuation and expansion of current nutrition services provided throughout La Crosse County Communities Putting Prevention to Work Contract. The FTE positions presented in this Resolution are currently authorized by the ARRA Obesity grant that will conclude on 12/31/12. The Harvest of the Month grant is over three years and will create some sustained efforts for the Harvest program. If the grant ends and there is not another grant available, the positions will sunset. **MOTION** by Veenstra/Johnson to approve the Resolution Re: Accept Contract for Harvest of the Month Partnership. **Motion carried unanimously.**

Family Policy Board Executive Committee Membership

Karin Johnson will be chairing the executive committee of the Family Policy Board when she returns at the end of summer. Mormann updated Attachment 1 to the Health Department Director's Report in the packet, Federal Funding thru Multiple Agencies.

Mormann initiated discussion on offering opportunities to board members to better become orientated with the Departments.
