

ORDINANCE #1-2006

AN ORDINANCE TO REPLACE ORDINANCE #1-2002 AND #1-2004 SETTING SPEED LIMITS WITHIN TOWNSHIP BOUNDARIES

The Holland Town Board, Township of Holland, La Crosse County does ordain as follows:

Section 1. General Provision.

The provisions of Sections 346.57, 346.58 and 346.59, Wis. Stats., relating to the maximum and minimum speed of vehicles are hereby adopted as part of this Section as if fully set forth herein except as hereinafter specified pursuant to Sec. 349.11(3)(c), Wis. Stats.

Section 2. Speed Limits 40 m.p.h.

The maximum speed limit of forty (40) m.p.h. is hereby established on the following streets, roads or highways pursuant to Sec. 346.57(4)(g) and/or (j), Wis. Stats.: Old NA from County Road HD west 1.5 miles

Section 3. Speed Limits 35 m.p.h.

The maximum speed limit of thirty-five (35) m.p.h. is hereby established on the following streets, roads or highways pursuant to Sec. 346.57(4)(g) and/or (j), Wis. Stats.:

- (3) Briggs Road south of MH
- (4) Council Bay Road .6 miles from Hwy 53 to its termination at County Rd T

Section 4. Speed Limits 30 m.p.h.

The maximum speed limit of thirty (30) m.p.h. is hereby established on the following streets, roads or highways pursuant to Sec. 346.57(4)(g) and/or (j), Wis. Stats.:

Section 5. Speed Limits 25 m.p.h.
