HUMAN SERVICES DEPARTMENT AND BOARD UPDATES

HS Director Update: Jason Witt

Jason provided a summary of some of the ways in which Human Services is changing practices in response to Covid-19.

- Building access restrictions impacting the La Crosse County Administration, Health and Human Services and the Law Enforcement Center buildings.
- Most employees began working from home and minimizing face-to-face contacts by using telephone and video conferencing.
- Human Services provided staffing assistance to two city of La Crosse homeless shelters.
- The Intake/Triage process for the Integrated Support and Recovery Services section became a telephone and email process instead of the Wednesday morning walk-in process.
- The Out-Patient Clinic has continued to provide some face-to-face contact where necessary. Prescribers have shifted to telehealth appointments.
- Admissions to the Juvenile Shelter and Detention have been reduced to emergency situations only and include a mandatory quarantine of new admissions.
- The Adult Justice Support Services unit suspended on site drug and alcohol testing and began to use alternative methods including remote units and sweat patch testing in priority cases.
- There has been an increase in all environments in cleaning protocols and use of Personal Protective Equipment.

- 2. What has worked best for your agency in engaging clients during this public health emergency?

- 5. What are your re-opening plans?
