PRESENTATION:

Safe Place – A potential new program for the La Crosse Community: Tom Berkedal is the Executive Director at LevelUp, a partnership to end domestic and sexual violence (formerly Coulee Region Voices of Men). LevelUp is looking into starting a new program called "safe place". Tom shared a video with us to give an introduction, the link to this video is:

"Safe place" locations could be any business, restaurant, organization, fire station, etc. LevelUp is currently in the stage of educating and gauging the need for this possible program in the community. Bridget Todd-Robbins feels there is a need for this program in the community. Catherine Kolkmeier encouraged Tom to talk to the student health center. Mary Kay asked if there is a structured training for volunteers? Tom told the group that the national organization for "safe place" would provide the training. Heidi Odegaard suggested that with two large health organizations in the community with residency programs, this group of individuals would be a great resource to tap into. You would have a continuous source of professionals.
