Hospice Utilization	Aging & Disability Resource Center (ADRC)	La Crosse County's hospice utilization is increasing! About two years ago, hospice utilization for La Crosse County was nearly 40%, compared to the State of Wisconsin at about 60%. As of 2nd quarter 2021, La Crosse County was at 49% with consistent increases over the three most recent quarters of Medicare Claims data reported by Trella Health. Why is this important? Studies have shown hospice care can dramatically reduce hospitalizations/rehospitalizations. Hospice is covered by Medicare, Medicaid, and most private insurance and is available 24/7, delivered directly wherever the individual calls home. Children's Long- Term Support Waiver	Children's Long-Term Support Waiver (CLTS)/ Integrated Support & Recovery Services (ISRS)	 Every 5 years the Wisconsin Department of Health Services (DHS) is required to renew the CLTS program application with the federal government. With input from participants, families, counties, advocates and stakeholders, DHS updated its CLTS Waiver to help support children with disabilities and their receiving services. These changes will begin on January 1, 2022. Published Division of Medicaid Services (DMS) Numbered Memo 2021-09 and DHS Memo #P- 02184 Some of the changes include: New services Change in service names and descriptions to be more family friendly Revised incident reporting requirements Fewer types of restrictive measures allowed to protect the safety of children enrolled Standards for youth transitioning from the CLTS program Diagnosis specific program eligibility for children under the age of 6 5% rate increase through the 2022 CLTS Waiver Statewide Uniform Rate Schedule. Pre- and Post- Charge Diversion Treatment Alternatives and Diversion grant	Justice Support Services (JSS)	units to complete all the needed details to carry out the new requirements asked by DHS. Justice Support Services was awarded \$125,000 with a match contribution of \$41,667 for a total of \$166,667 for the Pre-and Post-Charge Diversion Treatment Alternatives and Diversion (TAD) grant through the WI Department of Justice. This grant was budgeted in for 2022 and will fund personnel and employee benefits for our diversion coordinator positions, funds a staff member to attend the National Association of Pretrial Services Agencies (NAPSA) conference, and pays for the Fire Call subscription that sends court reminders to clients. The grant period is January 1, 2022-December 31, 2022.
